



RENTAL GENERAL TERMS AND CONDITIONS

Article 1: DISCOUNT

The discounts presented in the www.LATITUDE-RANDO.com web-site are valid on the on-line bookings only, realized 7 days minimum before the 1st day of the rent. They are applicable for the Adult, Teen & Kid rentals excluding Ski Touring. For Ski touring and Miscellaneous -10 % discount all the season.

Article 2: MAKING AVAILABLE THE HIRED EQUIPMENT

The hired equipments remain under full responsibility of the customer as soon as collected by him. The customer shall ensure its conservation and shall make use of it with due diligence at all times. Taking possession of the hired equipments remains the responsibility of the person making the hire.

Article 3: RETURNING THE HIRED EQUIPMENT

All equipment available for hire is recognized as being in good condition and shall be returned as such. The equipment being numbered or marked shall be returned with the same numbers and the same mark. Any damage will result in the direct payment for the replacement or repair fees, in addition to the cost of hire, within the maximum limit of the equipment value as new, minus a depreciation deduction -15% per annum. Failure to return the rented equipment – regardless of the reason – will be charged to the customer on the basis of equipment value as new, minus a depreciation deduction -15% per annum, in addition to the cost of the hire.

Article 4: USAGE OF THE HIRED EQUIPMENT

The hired equipment is for the customer's personal use only, with no possibility of sub-hiring or lending even for free. The customer is sole judge of his ability to use the hired equipment. The customer attests to be able to use the rented equipment and pledges to use it cautiously, at no risk for third parties in accordance to the regulations in force.

Article 5: RESPONSIBILITY - GUARANTY

The customer benefits from following conditions:

1) Except when the customer signed the "Damage and Theft Guaranty" see paragraph 2 below, he is not covered for all the damages or theft of the hired equipments and engages his personal responsibility regardless of the reason. In that case, the equipment will be charged to the customer on the basis of equipment value as new, minus a depreciation deduction -15% per annum, in addition to the cost of the hire. However, the customer would not be responsible of latent defects of the hired equipment or of the non visible wear unfit for the usage for which it is intended, since the proof of these defects or wear can be brought by the customer.

2) Damage and Theft Insurance:

the customer can opt for a payable insurance during the collect of the hired equipments. This option allows the customer to be exempted from the obligation of payment in case of damage and theft of the hired equipments. A franchising always remains (see the conditions shown in the store). To allow the application of this guarantee, the customer will:

- in case of theft: supply to the store, within 24 hours, the original of the deposit for theft, delivered by the gendarmerie or the police.
- in case of damage: return the equipment damaged to the store. This one will have to be recognizable and complete.

Article 6: DURATION OF HIRE

The duration of the hired period is indicated on the contract of hire, the day beginning at 8 am and ending at 6 pm. This duration of hire cannot be modified without the written agreement of the store. Should the customer not return the equipment on the due date, he will be invoiced and shall pay all additional days of rental at the public prices shown in the store.

Article 7: IDENTITY

An ID card can be required before the delivery of the hired equipments.

Article 8: PLEDGE

According to the signed contract of hire and/or the prices and conditions shown in the store, the customer hereby expressly agrees that the store may appropriate, from his bank account, any due amount in case of late or non payment of repair or replacement costs, by using the credit card number and expiration date given by the customer.

Article 9: PAYMENT

The payment shall be made according to the contract of hire. Penalties of delay will be applied for late payment, rising for one and a half time the legal interest rate.

Article 10: MISCELLANEOUS

In case of discrepancies between the French version and the English version of this general terms and conditions, the provisions of the French version shall prevail.

The French Law shall be the sole applicable to any dispute of any kind whatsoever and the French Courts shall be of exclusive jurisdiction.
